# The 2010 Revised ADA Accessibility Guidelines Training

### Description

This live, instructor-led on-line program will provide attendees with an overview of the 2010 ADA Standards for Accessible Design and highlight those areas where accessibility requirements found in the New Jersey Barrier Free Subcode differ from federal accessibility requirements. Specifically, this course will focus on: problem application areas in commercial facilities, accessibility requirements in existing facilities and accessibility requirements to and within special occupancies. We will also focus on the new guidelines for toilet rooms and other aspects of the built environment.

### Topics that will be covered

- Effective dates for the 2010 ADA Standards for Accessible Design and a review of Title II Program Access obligations and Title III Barrier Removal obligations.
- Major differences between 1991 ADAAG and the 2010 ADA Standards for Accessible Design - including information on how the 2010 Standards have been harmonized with model building codes (i.e. the IBC and ICC ANSI A117.1). Specific topics covered will include:
  1. Interior & Exterior Accessible Routes (including accessible doors, ramps, walking surfaces, lifts, etc...)
  2. Accessible Parking
  3. Toilet room Accessibility

### **Learning Objective 1:**

Participants will develop an awareness of the new US Department of Justice 2010 ADA Standards for Accessible Design. Specifically covered will be effective dates, safe harbor provisions and a review of the layout of the 2010 ADA Standards for Accessible Design.

### **Learning Objective 2:**

Participants will leave the session with an understanding of the application of the 2010 ADA Standards for Accessible Design for existing facilities that cannot use the Safe Harbor provisions - using the Title II (Program Access) and Title III (Barrier Removal) standards.

### **Learning Objective 3:**

Participants will be able to identify the changes from 1991 ADAAG that are found in the 2010 ADA Standards for Accessible Design for toilet rooms, accessible routes, parking and other special occupancies.

### **Learning Objective 4:**

Participants will gain an understanding of those areas where the New Jersey Barrier Free Subcode & ICC ANSI A117.1 contain accessibility requirements that differ from the 2010 ADA Standards for Accessible Design.
